



Guidelines II Khasi

KA APPLICATION BAD JINGPYNTREI KAM IA KI JINGTREI (SCHEMES/PROJECTS) DA KI NONGIOH PISA JINGIARAP (BENEFICIARIES)

Kumba ka SPV Society ka pdiang ia ki aplikeshon (application) na ki paidbah ia baroh ki schemes, yn kham pyrkhath kyrpang nyngkong ia kito ki scheme ka roi ka par ba iadei bad ka rep ka riang bad rep soh (agriculture and horticulture) bad kito ki kam ba don jingiadei bad kitei ki scheme.

Ha kaba jied ia ki beneficiaries yn kham pyrkhath nyngkong ia kito kiba la ioh jinghikai (training) lane ia kito kiba la ju tip bad mlien ha ka trei kam (experience) ha kano ka jaid kam. Hynrei ha kaba iadei bad ki kam ri jingri (Animal Husbandry and Veterinary schemes), tang kito kiba don hapoh kano kano ka SHG/Society yn pdiang ia ki application.

Kito ki bym shym la ioh kano kano ka 'training' lymne 'experience' ba iadei bad ka kam lane ki bym dei na ki Seng SHG ne Society, ki dei ban pyni ia ka jingkwah bad jingmynjur ban leit ban shah training hadien ba la jied ia ki kum ki beneficiaries.

Ia ka pisa ai jingiarap (financial assistance) yn nym ai/pyllait shisien ai hynrei da ki 'instalment'. Ha kaba pyllait ia ka pisa instalment ba ar ne hadien habud ki beneficiaries ki donkam ban phah ia ka report ba iadei bad ka jingpyntrei kan lyngba ka LPIC. Ka Committee (LPIC) kan sa ai ia la ka jong ka 'recommendation' kat kum ka jingleit khmih jong ka ia ki jingtrei. Ka LPIC ka lah ban report sha ka Dorbar Shnong shaphang kino ki jingleh bym salia ne leh kulmar jong ki 'beneficiaries.' Ka rai jong ka Dorbar Shnong kan long kaba kut bad kaba dei ban kohnguh da baroh ki beneficiaries.

Shaphang kano kano ka kam ba bud (second phase) lada don, ia kane yn lah ban pyrkhathadien ba shem ba ka jingtrei ba nyingkong ka long kaba biang bad iaid beiti kaba ka SPV Society ka shem.

Ha kaba iadei bad ka jingai sanction pisa jingiarap (financial assistance) ki beneficiaries kin hap ban soi (execute) ia ka Soskular (Memorandum of Agreement) MOA bad ka SPV Society lada donkam, bad ki dei ban bud thik ia ki kyndon ba la buh ha ka MOA. Lada don kano kano ka jingbym lah ban bud ne leh kat kum ki kyndon ba la buh ha ka MOA, ha kum kita yn hap ban pyndonkam ban leh (take action) kat kum ki kyndon ba la ia mynjour ha ka MOA bad ruh da kano kano da kumwei pat kat kum ka jingrai ka Shnong halor kata.

Ia ki pisa (financial assistance) yn ai da ka cheque. Ka dei namar kata ba baroh ki beneficiaries kin hap ban plie 'bank account' bad kano kano ka tnat jong ka State Bank of India lane ka Meghalaya Cooperative Apex Bank lane bad kano kano ka bank (nationalized bank).

Kawei pa kawei ka ing (family) ba ioh pisa jingiarap kan iohg tang kawei ka project/scheme hapoh ka por 3 snem. Ia kino ki jingkyrpad shaphang kiwei pat ki scheme hadien habud yn sa pyrkhath ban pdiang tangba lada shem ba ka jingpyntrei kam ia ki scheme ba ioh mynshuwa ki long kiba jop bad iaid beiti. Ka SPV Society ka don ka hok ban nym ai jingiarap shuh hadien habud ia kito ki ing (beneficiaries) SHGs/Societies kiba pyndonkam bakla ia ka pisa ba ai sha ki da ka SPV Society.

Katba ka SPV Society kan pyrshang ban pynioh ia kito ki jingdonkam na ki Department bapher jong ka Sorkar, ha kajuh ka por, ki beneficiaries ruh ki lah ban pyrshang ban ioh ia kine.

Kumba ka SPV Society kam shym don kino kino ki 'prescribed form' ba iadei ban apply financial assistance ki beneficiaries ki lah ban apply kumto (on plain paper) da kaba ai ia ki jingtip shaphang ki jaka puta ba don, ka area, ki kot ki sla ba iadei bad ka jaka ba dei ban da pynshisha da ki bor shnong bad ruh shaphang u nong apply ban pyni ki certificate shaphang ka jingpule, training ba la ioh bad kiwei kiwei. Ia ka application lah ban phah sha ka SPV Society lyngba ka LPIC jong kata ka shnong hi.

Ka jaka ha kaba yn pyntrei ia ka project ka dei ban long ha kata ka rukom ka ban nym wanrah ia kano ka jingpynthut ne jingwit ia ka shnong ka thaw. Na ka bynta kane ka daw kito ki beneficiaries ba ia dei bad ka kam ri-jingri (Animal Husbandry & Veterinary scheme) kin hap ban pynioh ia ka NOC (No Objection Certificate) na ki bor shnong ha kaba iadei bad kaba pan/ai financial assistance.

Ki estimate ba iadei bad kitei ki scheme ba kdew haneng la pynbiang hadien ba la ia dep ioh jingmut jingsngewthuh bad ki Department bapher jong ka Sorkar Meghalaya. Ki applicant - beneficiaries kin nym donkam shuh ban phah estimate. Ki dei tang ban shu pyni shai shaphang ka jingdon jaka puta, ka area, ka kyrteng bad ka jaka ha kaba ka khyndew ka don ryngkat bad ki kot ki sla jingthoh jingkdew ba la pynshisha da ki bor shnong ia mynta, kumno la pyndonkam ia ka jaka, bad ruh ka kyrteng bad 'address' bad 'household number' ba la ai da ka SPV Society ha kaba leh ia ka 'baseline survey'.

Lait noh kito ki kam ba iadei bad ka 'Fisheries' ba la kdew ha sl. (viii), Piggery (breeding) ha sl.(x) bad Dairy ha sl. (xv) ha kaba yn don tang kawei ka sien (Phase) bad kawei ka unit, na ka bynta kawei ka beneficiary yn don tad haduh ar tylli ki unit (maximum) ban pyntrei kam 2 sien (2 phases). Ha ka sien nyngkong (first phase), yn pyllait pisa iarap (financial assistance) na ka bynta ka 'first unit' ha ki instalment. Ia ka financial assistance na ka bynta ka 2nd unit yn pyllait ha ka sien ba ar (second phase) tang lada ka SPV Society ka shem ba ka jingpyntrei kam ba iadei bad ka 'first unit' . ka sien nyngkong ka long kaba beit ba biang bha. Hadien ba la dep pyntrei ia ka 'First unit' ha ka 'First Phase' ki beneficiaries kin lah ban kyrpad ban pan jingiarap pisa na ka bynta ban pyntrei kam ia ka 'Second unit' ha ka 'Second Phase' bad dei ban don ki jingthoh ban pynshisha shaphang ka jingtrei ba la dep ha ka 'First Phase' ryngkat bad ka jingai 'recommend' na ka LPIC. Ka rai jong ka SPV Society ha kane kan long kaba kut.

Shuwa ban pyllait pisa instalment ki beneficiaries ba la dep jied (selected) ki dei ban pynkhreh treikam kum ha kaba pynioh ia ki tiar ban thaw ia ki sem , ban pynkhuid ia ka jaka trei kam bad kiwei ki jaid kam ban pynlut na lade hi.

Tang uwei u applicant na kawei ka ing lah ban pyrkhath ban ai pisa iarap na ka bynta kawei ka unit ba la kdew haneng. Ki bor ba ai 'recommend' ki dei namar kata nyngkong eh ban da peit bniah shuwa ban phah ia ki application sha ka SPV Society.

Ia ki 'Plan bad Estimate' ba iadei bad ki 'Livelihood Scheme' la suh lang bad ki 'Guidelines' bad ki applicant/beneficiaries ki dei ban bud thik kat kum ba la bthah/pyni hangta.
