



Guidelines IV Khasi

KA JINGJIED IA KI BENEFICIARIES DA KA SPV SOCIETY

1. Hadien ba la ioh pdiang ia ka jingai recommend na ka Local Project Implementation Committee (LPIC), ka SPV Society kan sa register ia ki aplikeshon ba iadei bad kawei pa kawei ka shnong bad ki kam ba iadei.
 2. Ka SPV Society kan sa khmih bad rai hi shaphang katno tylly ki beneficiaries yn pyrkhat/pdiang ha kawei pa kawei ka shnong ka ban shong kat kum ka jingdon ki biew ne ki ing bad ka jingling ka jaka bad kumta. Ha kaba leh kumne, yn kham pyrkhat ia kito ki scheme rep (agriculture-horticulture).
 3. Shaphang kaba pyrkhat ia kino ki jaid kam yn shim nyngkong, (prioritization) ba iadei bad kin non-livelihood/community projects, ia kane kan shong ha ka SPV Society ban leh.
 4. Ha kaba jied ia ki beneficiaries, ka Society nyngkong eh kan pyrkhat bad pdiang ia kito ki beneficiaries kiba la ioh training ha ki jaid jingtrei bapher bapher. Kiba ar ban pyrkhat/pdiang kan long ia kito kiba dei ki Societies/Groups ba la dep register ne la ithuh da ki bor (authorities). Kaba khatduh ban pyrkhat/pdiang kan long ia kito kiwei pat kiba ym pat ioh training lane ki bym dei hapoh kano kano ka Society/Group. Lada shem ba ki aplikeshon ki bun palat eh ia kaba yn nym lah ban pdiang lut, ha kum kita yn hap ban pyndonkam da kaba jied khalai nusib.
 5. Lada don ki aplikeshon kiba ym lah ban pdiang kat kum ka 'budget' ba la mang ha kata ka snem, ia kita ki aplikeshon lah ban pyrkhat ban pdiang ha ka budget jong u snem ban wan.
 6. Ki beneficiaries kim dei ban phah aplikeshon palat na kawei ka shnong, lane palat uwei u member na kawei ka ing. Lym kumta, yn nym pdiang ia kum kita ki aplikeshon, lada shem.
