



Guidelines III Khasi

KA JINGPYNTREIKAM IA KI 'EMPLOYMENT-GENERATION PROJECTS' (KI KAM PYNROI IA KA JINGIOH KAM IOH JAM)

Ka jaka ba la mang (mandated area) ia mynta hi, kam don kino kino ki project ban lah ban ai jingtrei ia ki briew. Namakata, ka long kaba donkam eh ba dei ban pynshlur kum ia kita ki project. Ka jaka hi ka long kaba don lypa bad ba bit bha ha kaba thung ki jaid jingthung kum u slasha, u rubber, u coffee bad kiwei bad ban seng/thaw ia ki industries ba iadei (agro-based processing industries). Shaphang kumno ban phah application ha kaba iadei bad kane, kine harum ki long jingbthah (guidelines):-

Ka jingheh ka jaka (unit size) na ka bynta ban pyntrei kam ia kine ki jaid project kan long 1 hectare lane 2 acre shiteng (21/2 acres). Uwei u applicant un lah ban ioh jingiarap ym palat ia ka 20 unit.

Kiba kwah apply ki dei ban phah ha ka 'prescribed proforma' ia kaba ki lah ban ioh na ka SPV Society.

Ki aplikeshon ki dei ban don (suh lang) bad ki kot ki sla bad jingthoh jingkdew ba don jingiadei bad ka jaka ne ki jaka ba la tyrwa ban pyntrei ia kum kita ki jaid jingtrei ryngkat bad ka NOC na ki bor shnong.

Hadien ba la pdiang da ka SPV Society ia kita ki aplikeshon, yn sa pyrkhath bad iakren da ka Society bad ka 'Rubber Board,' 'Tea Board', 'Coffee Board', kat kum ka rukom ba dei ban leh, bad ki nong apply kin hap ban mynjur ban register ia kita ki jingrep jingthung (plantations) bad kata ka Board of Government of India ba iadei bad kata ka kam.

Hadien ba la dep register kumta, ki applicant-beneficiaries kin hap ban kohnguh bad bud ia ki jingbthah kat kum ba ai da kita ki bor (Board) bad ban pyntrei kam kat kum ka jingbthah jong ki.

Kano kano ka pisa financial assistance ban ai da kita ki bor pyniaid (Boards) yn ioh pdiang beit da ki applicant kum ka bynta jong ka financial assistance ba la bhah bad ai na ka bynta ka scheme/project.

Shiteng (50%) na kaba sah na ka estimate yn bei/iarap da ka SPV Society kum ka financial assistance ia kaba yn pyllait/ai ha ki instalment ha ka por kaba dei ia kaba yn kdew pynshai ha ka MOA kaba yn nym palat ia ka 50 lakh tyngka.

Ha kaba iadei bad ki 'agro-based processing industries,' kiba apply, nyngkong eh ki dei ban wad lad da lade hi kumno ban pynbiang ki report (preliminary report) ba iadei bad ka project da kaba wad jingtip jingiarap na ki department bapher jong ka Sorkar. Ynda la ioh ka jingmynjur bad sanction na ka bynta ka jingioh pisa jingiarap na ki department Sorkar, ki beneficiary/applicant kin sa lah ban phah aplikeshon financial assistance na ka SPV Society ban phah ryngkat bad kita ki clearance/scnction, DPR etc. ba ioh na ki department Sorkar. Ka SPV Society ka lah ban iarap haduh "50% of the remaining balance of the estimate" kat kum ka DPR ia kaba yn pyllait ha ki instalment kat kum ba la kdew shai ha ka MOA, ka ban nym palat ia ka 50 lakh tyngka.

Ha kaba iadei bad ki kam fishery (fishery project) ba kham heh, ha kaba ka jingheh jong ka pung dohkha ka long palat ia ka 0.4 hectare land 1 (shi) acre, kiba apply nyngkong eh kin hap ban iakren sngewthuh bad ka Aquaculture Mission of the State Government na ka bynta ban shna ia ki plan bad estimate bad na ka bynta ka 'financial assistance.' Hadien nangta, ki beneficiary applicant ki lah pat ban pan financial assistance shuh na ka SPV Society ha kaba dei ban phah ruh ryngkat bad ki plan and estimate bad sanction. Ka SPV Society kan lah ban ai pisa financial assistance haduh 50% na ka pisa ba duna (50% of the uncovered amount of estimated expenditure) ia kaba yn pyllait ha ki instalment ba la kdew shai ha ka MOA, ka ban ym palat ia ka 50 lak tyngka.

Katba long kaba lah ia ki briew ban trei ha kum kita ki unit dei ban wad bad shim napdeng ki trai shnong ba shong ba sah ha kata ka jaka hi.

Ia kino kino ki project ki bym lah ne hap kat kum kine ki guidelines, ia kum kita yn rai da ka Board jong ka Society ka ban shong eh kat kum ba iadei ban leh kumta.
