



Guidelines V Khasi

Ka jingpyntreikam ia ki Infrastructure Projects (thaw ing skul, surok bad kiwei)

1. Ka SPV Society ka pdiang ia ki application ba kat kum ka form ba la buh na baroh ki Shnong, ki bor pyniaid skul bad kiwei kiwei na kito ki shnong ba hap hapoh ka Project area ha kaba dei ban ioh jingiarap ha kaba shna ia ki surok, ing skul etc kat kum ba kdew hangne harum :-
 - a. Ing skul bad toilet (school building & toilets)
 - b. Madan ialehkai ha skul (school playgrounds)
 - c. Ki hostel school (school hostels)
 - d. Ing Shnong (community hall)
 - e. Ki madan ialehkai ha Shnong (village playground)
 - f. Ki surok bad jingkieng (roads and bridges)
 - g. Ki umbam umdih (water supply)
 - h. Ki lynti ia id kjat hapoh Shnong (village footpath) bad kiwei kiwei.
2. Ka SPV Society ka la dep mynjurbad buh ha kaba iadei bad ka jingai jingiarap ban shna/thaw ia kum kine ki jaid jingpyntrei kat kum ka bhah (ceiling) ba la kdew hangne harum :-
 - a. Construction of Primary School (Class I to IV) building & toilet - Rs. 30 lakhs
 - b. Construction of Upper Primary School buildings (Class V to VII) With toilet - Rs. 30 lakhs
 - c. Construction of Elementary School building with toilets (Class I to VII) - Rs.50 lakhs
 - d. Construction of Secondary School buildings with toilets (Class VIII to X) - Rs. 50 lakhs
 - e. Construction of Secondary School Building with toilets (Class I to X) - Rs.150 lakhs
 - f. Construction of Secondary School Building Class XI to XII - Rs. 150 lakhs
 - g. Construction of School Playgrounds - Rs. 25 lakhs
 - h. Improvement of School playground - Rs. 5 lakhs
 - i. Construction of hostels - Rs. 20 lakhs
 - j. Construction of Community Halls - Rs.125 Lakhs
 - k. Construction of village playground with open sitting galleries (village population 2000 +) - Rs. 150 lakhs

Ha kaba iadei bad ka jingtrei 'water supply' 'Roads and bridges' bad 'village footpath' etc yn nym don ka bhah (ceiling)- Kane ka shong kat kum ka estimate na ka bynta kata ka jaid jingtrei.

3. Namar bym biang bha ki briew (technical manpower), Ka SVP Society ka la dep bthah lypa ia ki Shnong ba ki dei ban thaw bad pynbiang ia la ki jong ki estimate/DPR ba iadei bad kino kino ki project bad ban phah ia ki application sha ka SPV Society. Dang shen ka SPV Society ka la dep iasoi bad mynjour ia ka MOU bad ka Meghalaya Government Construction Corporation (MGCC) ba ha kaba iadei bad ki kam ban survey, shna estimate/DPR bad ruh ban pyntrei kam ia kito ki infrastructure projects ba hap hapoh ka jingpyniaid ka Society.
4. Kat kum kane ka jingiateh kular (MOU) bad jingpynbeit, ki bor pyniaid Shnong bad bor pyniaid skul etc ki lah ban phah ia ki application (katkum ka form ba la buh) ba iadei bad kum kita ki jaid kam (scheme) bad ban phah sha ka SPV Society lyngba ka LPIC kumba ju leh. Hadien ba la ioh pdiang ia kum kita ki application ba ia dei bad ki project – roads, water supply etc yn sa phah pat sha ka MGCC ba kin peit bad leh ia ka kam ban survey bad peit bniah (investigation).
5. Ki bor pyniaid Shnong ki dei ban ia snoh kti lang ban iarap ia ka MGCC ha kaba ia dei ban leh ia ki kam ban survey etc bad ha kaba iadei ban ioh ruh ia ka jingiasngewthuh jingmut bad jingmynjour bad ki trai jaka ban pyntrei ia kum kita ki jaid project khlem da hap ban siew dor ei ei (free of cost).
6. Ka MGCC kan shna ia ka DPR ryngkat bad ki plan bad estimate bad nangta kan phah sha ka SPV Society ban ioh jingmynjour bad hadien nangta kan sa pyntrei ia ka kam kat kum ba la ia mynjour ha ka MOU. Hadien ba la dep pyntrei ia kum kita ki project, ka MGCC kan sa aiti sha ka SPV Society bad ka Society pat kan sa aiti sha ki bor pyniaid Shnong (village authorities).
7. Ha kaba iadei bad ki School building, Community Halls, Playgrounds ki nongpanjingiarap (beneficiaries) ki dei bad phah ia la ki estimate/DPR ba la dep shna da ki briew jong ki (qualified consultants) bad ban phah pat ia ki plan bad estimate/DPR sha ka SPV Society. Ha kum kita ki jaid jingpyntrei, ki bor pyniaid Shnong/skul ki lah ban buh la ki jong ki contractor ban pyntrei hapoh ka jingpeit jingbthah (supervision) jong ki Consultant ba phah da ka SPV Society.

Lada ki bor pyniaid ki sngew donkam ki lah ruh ban aiti ban pyntrei ia kum kita ki jaid project da ka MGCC.

8. Lada ki bor pyniaid Shnong lane skul ki kwah ban pyntrei hi da lade ia ki project bad kiba don la ki jong ki qualified consultant ban peit ia ki jingpyntrei, ia ka pisa ba iadei bad kum kita ki jingtrei yn ai da ka SPV Society sha ki contractor ba pyntrei ia ka kam kat kum ka jinglut bad ka kam ba ki la dep trei ka ban don ryngkat bad ka report/recommendation ban

ai da u consultant ba peit ia ka kam. Ha kaba iadei bad kane ka kam, U contractor ba la thung ban pyntrei ia ka kam u dei ban phah ia ka bill bad ban ioh ka jingmyanjur (recommend) na u consultant. Haden ba la dep pyntrei, U contractor un sa aiti sha ki bor pyniaid shnong /skul (Management) bad ban ai jingpyntip sha ka SPV Society.

9. Ha kaba iadei bad ki jingshna painkhana (latrine), ka juh ka rukom dei ban bud kat kum ka para 8 haneng bad baroh ki dei ban ion ka jing recommend na ka Shnong.
